

World Bank Program of CDM/JI National Strategy Studies

Objectives:

- Increases fundamental understanding concerning the opportunities provided by the KP flexible mechanisms
- Develops strategic approach to the KP flexible mechanisms, help establish necessary prerequisites
- Supports an "equal CDM/JI level" dialogue of host countries with industrialized countries

NSS Program - Focus

- Reflects the UNFCCC process
- Creates links between sustainable development and CDM by promoting market mechanisms (CDM/JI/ET)
- Facilitates the transfer of advanced/clean technologies while supporting sustainable development
- Stimulates the role of the private sector in technology transfer
- Applies practical experiences: "deal making"
- Facilitates subsequent follow up/implementation

NSS Program - Features


- Host country driven /ownership / Govt.'s commitment (co-financing)/participatory mode
- Stimulates/contributes to the national climate change process by advancing, broadening and/or deepening the climate change issues
- Flexible to reflect demand for CB (KP)/level of host country's advancement/changing needs
- Comprehensive/complementary approach
- Innovative character (LULUCF)

- Institutional framework in each host country (dialogue with Govts.)
- Donor financing, TA
- Program administration

Some Outcomes of the Studies

- Promotes the Govt's role in the CDM area by establishing strategy, determining prerequisites & addressing barriers (CDM/JI dialogue at the Govt's level through an active role of the Steering Committee, workshops)
- Supports PARTNERSHIP between the Govt. & private sector (PPP)
- Enhance the negotiation skill for the KP negotiations (COPs)
- Addresses high priority/innovative issues in host countries

NSS Program - Experiences

- Complementary LOCAL plus GLOBAL Approach (Synergies)
- Use existing Drivers & Movers (Sector Programs-Energy Savings, Renewables, Sustainable Development)
- Scope for closer cooperation with other programs (e.g. Centers for Clean Production (Swiss/UNIDO, UNDP, UNEP, UNCTAD, WBCSD, bilateral, others)
